Please explain your answer.

There is concern that the responsible person needs sufficient training in elements related to fire doors and architectural ironmongery/building hardware. a lack of competence in these areas are of grave concern. There is also concern regarding the competence of the operatives/organisations that undertake the inspections and assessments, plus those who undertake the actual repair and maintenance. We often see situations where worn out or damaged hardware, hinges, closers, locks etc have been replaced by the wrong items – normally to save money and the responsible person is not able to see the difference due to a lack of training and awareness. GAI are also concerned that despite section 17 stating as follows regarding maintenenace "17.—(1) Where necessary in order to safeguard the safety of relevant persons the responsible person must ensure that the premises and any facilities, equipment and devices provided in respect of the premises under this Order or, subject to paragraph (6), under any other enactment, including any enactment repealed or revoked by this Order, are subject to a suitable system of maintenance and are maintained in an efficient state, in efficient working order and in good repair.) it is often the case that fire doors which are a vital element of passive fire protection in a building - and their corresponding ironmongery are not regularly inspected and maintained. it is our view that this is of vital importance.
